PROSPECTUS FOR ADMISSION TO D.PHARM COURSE IN

CHRISTIAN MINORITY INSTITUTIONS FOR THE ACADEMIC YEAR 2017-2018

I. INTRODUCTION

- 1.1 This prospectus relates to admission to D.Pharm course in Lisie College of Pharmacy-Kochi, Caritas College of Pharmacy-Kottayam and St.Joseph's College of Pharmacy-Cherthala.
- **1.2** The Name, Address, Code of Colleges and their intake are given below.

- **1.3** This prospectus contains rules and conditions of Admission to D.Pharm course for the Academic year 2017-2018 in the above said institutions.
- **1.4.** This prospectus is subject to modification / deletion as may be deemed necessary by the said institutions and also subject to further orders if any passed by courts of law.
- **I.5** Each College has its own policies of reservations which are separately explained in the respective pages (Annexure –I, II & III) relating to each college.

II. ELIGIBILITY FOR ADMISSION

2.1 NATIONALITY

Candidates must be citizens of India/Children or dependents of Non Resident Indians.

2.2 ACADEMIC:

a) Candidates who have passed the Higher Secondary Examination/Pre-degree with Physics, Chemistry and Biology/ Mathematics/Biotechnology/Computer Science as optional subjects or equivalent there to are eligible

Or

VHSE of Kerala from 1994-1995 sessions with group A and B only are considered as equivalent exam for admission to D.Pharm course(Group A - NCERT Syllabus in Physics, Chemistry and Mathematics / Biotechnology/Computer Science; Group B - NCERT Syllabus in Physics, Chemistry and Biology.)

Or

An equivalent examination approved by the Pharmacy Council of India will be eligible for admission to D.Pharm.

b) Rounding off of the percentage of marks to the nearest whole number is not permitted.

<u>Candidates who have passed their qualifying examinations from the states other than</u> <u>Kerala shall produce the certificate of recognition and equivalence of qualifying examination.</u>

2.3 AGE:

The applicant should have completed 17 years of age as on 31.12.2017. Candidates above the age of 35 as on 31.12.2017 are not eligible for admission.

III. HOW TO APPLY

3.1 The common prospectus along with application form can be obtained directly from any of the above said three college offices on payment of Rs.300/- or by sending a request along with a D.D. for Rs.350/- drawn in favor of the Principal of any of the member colleges. Application form can also be obtained from following branches of South Indian Bank (SIB) by payment of Rs.300/-

- **3.2** The application shall be submitted as detailed below.
- a) One single application is sufficient for all the three colleges.
- b) The candidate should indicate the order of preference of the college for admission in the specific format provided in the application form.
- c) Completed applications should be submitted to the respective college of first choice either by Registered post or by hand. Applicants shall obtain acknowledgement from the respective college office, if the application is submitted in person.
- d) Candidate who wish to apply to Reserved seats in Community Quota may do so on the basis of the reservation policy of each college as provided in the Annexures I/II/III of the respective Colleges, by marking in the space provided in the application form (copies of relevant documents to prove eligibility to reservation as mentioned in the prospectus have to be attached).
- e) Applications submitted should be complete in all aspects. The candidate should fill all the items in the application form in his/her own handwriting.

3.3 Documents to be submitted along with the application form

- 1. Copy of the SSLC Certificate (Self attested) to prove date of birth.
- 2. Copy of P.D.C./XII / VHSE Mark Cards (Self attested).
- 3. Copy of Character and Conduct Certificate (Self attested).
- 4. In cases where the candidate claims any sort of reservation/preference, provided for each college Documents to prove such claims as described in Annexure I/II/ III by each college.
- 5*. A medical fitness certificate showing suitability to undergo the course. (*submit it only at the time of Admission)

Note: Candidates are instructed not to enclose any original certificate along with the application.

Applications not accompanied by documents in proof of claims there in, is liable to be summarily rejected without further intimation. Documents/Certificates furnished after submission of the application will not be entertained under any circumstances. No opportunity will be given to incorporate any details or document after the submission of the application. Late and incomplete applications will be rejected.

IV PROCEDURE FOR SELECTION

4.1 Selection will be based on the rank list prepared on the basis of marks obtained in Physics and Chemistry in the qualifying examination. If there is a tie, marks obtained in Chemistry will be considered, if there is still a tie, marks obtained in English will be considered, if there is still a tie, candidate with higher age on the date of counselling will be considered.

4.2 Percentage of seats set apart under various heads

Details of seat allocation under various categories in the respective colleges are mentioned in the Annexure – I / II/ III of this prospectus.

- **4.3** Furnishing false information or particulars would result in the forfeiture of admission to the course. In addition; it will invite the relevant provisions of the criminal law of the land.
- **4.4** After scrutiny of applications, merit list of the different categories will be published in the notice boards and website of the member colleges.
- **4.5** Admission will be on the basis of a centralized counselling based on the preferential options of candidates to the seats available.
- 4.6 The venue of centralized counselling will be at Caritas College of Pharmacy, Caritas Hospital, Thellakom, Kottayam on 27.07.2017 at 10.30 a.m. (Ph:0481-2790638)

V. ADMISSION

- **5.1** For genuine reasons, respective managements will have the right to deny admission to any candidate even if otherwise eligible.
- **5.2** No marks will be allotted for interview.
- **5.3** Selected candidates shall take admission at the appointed time and date in the college concerned after paying the Tuition fee, Caution Deposit and Stationery fee, failing which the offer of admission will be cancelled.
- 5.4 SC/ST candidates will have to pay the normal fees. The fees will be refunded as and when the Government reimburses their fees to the college.

VI. REFUND OF FEES.

6.1 If an admitted candidate leaves the college after the closing date of admission, the candidate has to pay liquidated damages to the tune of full fee of the course. TC and other Certificates will be issued only after clearing all the dues.

VIII. CODE OF CONDUCT

8.1 Every student is required to adhere strictly to the code of conduct of the institution where the candidate has taken admission.

IX. <u>CAUTION</u>

9.1 PROHIBITION OF RAGGING.

Ragging / any type of misconduct towards any students either in the college campus or outside will be considered as a criminal offence and will be immediately reported to the police. Perpetrators will not be permitted to continue their study.

Every student shall at the time of admission furnish a character certificate from the institute where from he/she has passed the qualifying examination/the course last attended. Such a Certificate should mention the status of his/her behavioral pattern especially in terms as to whether he/she had displayed persistent violent, or aggressive behavior or any desire to harm others.
